With evidence-based programs, The Heroic Journey Behavioral Health and El Viaje Héroeico Salud Conductual, the Coalition equips children, teens, and parents living in poverty with the skills and tools necessary to break chronic, generational cycles and to build safe, hopeful, successful futures. Through YMCAs, non-profit partners, and public housing authorities, we seek out those who are experiencing a lethal absence of hope; we teach skills and tools including empathy, nonviolent conflict resolution, navigating peer pressure, resilience, healthy identity, ending bullying in all forms, and other life-saving skills in ways that research shows are relatable and highly effective.

We turn struggles into strengths — teaching children to be heroes for themselves and for their communities. Delivered free nationwide via our Partnership with YMCA of the USA, The Heroic Journey has been provided to over 500,000 young people, parents and educators at 1,800+ sites. Its 21 research-based lessons pair evidence-based tools with beloved, heroic narratives to teach resilience, emotional regulation, kindness, conflict resolution, resisting peer pressure, bullying prevention, and lifelong decision-making skills. With a companion component for parents/guardians, each lesson strengthens support at home. Independent evaluation by Hello Insight shows The Heroic Journey more than doubles youth proficiency on national skill benchmarks — from 41% to 83%.

This program is implemented by Dr. Frances K. Hurley, Ed.D. and M.Ed. Harvard.

4b (Code:) (Expenses \$ 119,500 including grants of \$) (Revenue \$ 144,337)

Our Spanish-language edition, El Viaje Heroico, is funded by the Florida Blue Foundation and Fundación Triple S (Blue Cross Blue Shield), in Partnership with the Florida State Alliance of YMCAs. We are implementing Year 2 of the program in Florida, and San Juan and Ponce, Puerto Rico, with strong early results.

This program also features work by Dr. Frances K. Hurley and by Dr. Sara Roldán, a Guatemalan-born psychologist working with Spanish-speaking families and public housing communities in San Diego.

Created in Partnership with Children's Mercy Hospital, the Coalition's Wellness and Nutrition Expansion teaches healthy screen use, physical activity, tools to curb emotional eating, and other essential self-care practices as core elements of mental and behavioral health. Initial funding for this 8-lesson program is provided by the Kemper Foundation.

We are currently translating the Wellness and Nutrition Expansion into Spanish.
